WHEREAS, in March 2015, the City Development Council of Marikina, headed by the City Mayor, Honorable Del R. De Guzman, approved Resolution No. 01, Series of 2015 which embodies its approval of the 2015 City Development Fund (CDF) Budget in the amount of One Hundred Fifty Five Million Two Hundred Four Thousand Four Hundred Eighty Five Pesos and Fourteen Centavos (₱155,204,485.14);

WHEREAS, said Resolution contains a list of the City's Community Development Fund Projects which are in line with the 7K Programs of the present administration;

WHEREAS, the list of programs was a result of the tedious study and brainstorming of the Members of the City Development Council such as the Barangay Captains of all the sixteen (16) Barangays in the City, the Chairperson of the Committee on Appropriation of the City Council, representatives from non-governmental organizations and representatives of the congressmen as provided for by the Local Government Code of 1991;

WHEREAS, funds necessary for the purpose shall be taken from the 20% of the Internal Revenue Allotment of the City for CY 2015 and from the savings and balances from continuing appropriation;

WHEREAS, Section 114 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that:

(a) The policies, programs, and projects proposed by local development councils shall be submitted to the sanggunian concerned for appropriate action.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled, to adopt the City Development Council Resolution No. 01, Series of 2015, entitled "Resolution Approving the 2015 City Development Fund Budget in the amount of One Hundred Fifty Five Million Two Hundred Four Million Four Hundred Eighty Five Pesos and 14/100 (PhP155,204,485.14).


RESOLVED FURTHER, that a copy of this Resolution be furnished the City Development Council and other concerned offices for their information and appropriate action.
