**ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE BUSINESS
PERMITS & LICENSING OFFICE, THIS CITY**

WHEREAS, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod, as the legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective City Government, and in this connection, shall:

“x x x (viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds x x x”:

WHEREAS, considering that the said office is responsible for the management, supervision and control of the licensing and inspection of all business establishments in the city, the creation of an additional plantilla positions are of great importance and necessary;

WHEREAS, the Business Permits & Licensing Office (BPLO) requested the creation of said plantilla positions in order to meet the demands of an increased number of business establishments and other trades in the city for monitoring and inspection;

NOW THEREFORE BE IT ORDAINED AS IT IS HEREBY ORDAINED by the CITY COUNCIL of MARIKINA in session duly assembled that:


SECTION 1. The following plantilla positions in the Business Permits & Licensing Office are hereby created:

Two (2)	License Officer I	Salary Grade 11
Two (2)	License Inspector II	Salary Grade 8
Two (2)	License Inspector I	Salary Grade 6


SECTION 2. This Ordinance shall take effect upon its approval.


