**ORDINANCE ESTABLISHING THE MARIKINA SATELLITE TREATMENT HUB
FOR PEOPLE LIVING WITH HIV AND PROVIDING FUNDS THEREFOR AND FOR
OTHER PURPOSES**

WHEREAS, Article XIII, Section 11 of the 1987 Constitution states that:

“The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social service available to all people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled women and children. The State shall endeavor to provide free medical care to paupers.”;

WHEREAS, Article III, Section 447, sub-paragraph (xii) of the Local Government Code of 1991 states that:

“(xii) Approves measure and adopt quarantine programs to prevent the introduction and spread of diseases.”;

WHEREAS, Human Immunodeficiency Virus (HIV) which causes Acquired Immunodeficiency Syndrome (AIDS) destroys the human body’s natural defenses against any sickness is classified as highly communicable disease;

WHEREAS, no effective cure for HIV currently exists, but with proper treatment and medical care HIV can be controlled;

WHEREAS, it is incumbent upon the City Government of Marikina to protect the health and welfare of its constituents from this dreaded disease by establishing a treatment facility to prevent and control the introduction and spreading of this disease in the City.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled that:

SECTION 1. The Marikina City HIV Satellite Treatment Hub shall be established under the Marikina City Health Office.

SECTION 2. The Satellite Treatment Hub shall serve as diagnostic, treatment and referral facility of people living with HIV and other sexual related diseases.

SECTION 3. The Satellite Treatment Hub shall operate from Monday to Friday from 8:00 am to 9:00 pm at Sundown Clinic.

SECTION 4. FUNDING. The City Government of Marikina shall allocate the amount of Three Hundred Thousand Pesos (Php 300,000.00) under the annual budget of the Marikina City Health Office for the operation, maintenance and activities of the Satellite Treatment Hub.



SECTION 5. Separability Clause. If for any reason any section of this ordinance, or any portion thereof, or the application of such section thereof, to any person, group or circumstances is declared invalid or unconstitutional, the remainder of this ordinance shall not be affected by such declaration and shall remain in force and effect.

SECTION 6. Repealing Clause. All other ordinances, administrative orders, rules and regulations or parts thereof inconsistent with the provision of this ordinance, are hereby repealed or modified accordingly.

SECTION 7. Effectivity Clause. This ordinance shall take effect upon its approval.
