**ORDINANCE GRANTING 50% REDUCTION TO ALL BUSINESS PERMITS
ISSUED BY THE CITY FROM CALENDAR YEAR 2016 TO 2020**

WHEREAS, Ordinance No. 27, Series of 2013 otherwise known as the Revenue Code of Marikina City provides for the categories of business taxes being paid by business owners in the City, the Time of Payment as well as the Surcharges & Interest on Unpaid Taxes, Fees, or Charges;

WHEREAS, with the growing expenses in running a decent business, the City Government of Marikina is desirous of extending assistance to the business sector by granting them a business tax reduction of 50% from Calendar Year 2016 to 2020;

WHEREAS, Section 16 of the same Code likewise states that:

"SECTION 16. General Welfare. – Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. x x x"

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby grants 50% reduction to all Business Permits issued by the City from Calendar Year 2016 to 2020.

SECTION 2. Repealing Clause. All ordinances and executive orders inconsistent with any of the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 3. Separability Clause. If for any reason or reasons, any provision of this Ordinance shall be declared unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.


SECTION 4. Effectivity. This Ordinance shall take effect starting January 1, 2016.
