ORDINANCE APPROVING THE REALIGNMENT OF SAVINGS INCURRED FROM THE UNUTILIZED QUICK RESPONSE FUND FROM PREVIOUS YEAR (CY 2015) OR 30% OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND

WHEREAS, the Marikina City Disaster Risk Reduction Management Office (MCDRRMO), was able to save an amount of Twenty Six Million Three Hundred Fifty Seven Thousand Forty Four Pesos and 40/100 (₱26,357,044.40) from the 2015 Quick Response Fund or 30% of the Disaster Risk Reduction Management Fund;

WHEREAS, in preparation for the possible occurrence of a calamity in the future, the MCDRRMO intends to utilize the aforementioned savings for the procurement of a Field Hospital in the amount of Twenty Three Million Pesos (₱23,000,000.00);

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby approves the realignment of the savings incurred from the unutilized quick response fund from previous year (CY 2015) or 30% of the Local Disaster Risk Reduction and Management Fund.


SECTION 2. This Ordinance shall take effect upon approval.

UNANIMOUSLY ENACTED by the SANGGUNIANG PANLUNGSOD of MARIKINA, this 8th day of June, 2016.


