ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF THE MARIKINA SPORTS PARK FOR CALENDAR YEAR 2016 IN THE AMOUNT OF TWENTY FIVE MILLION NINE HUNDRED NINETY ONE THOUSAND EIGHT HUNDRED SIXTY NINE PESOS AND SEVENTY SEVEN CENTAVOS (₱25,991,869.77)

WHEREAS, forwarded to the City Council for its review and consideration is the Supplemental Budget No. 2 of the Marikina Sports Park for Calendar Year 2016 which will be utilized for the repair, maintenance and improvement of various sports facilities, the structural assessment of the 8-storey Sports Building and the purchase of Christmas lights and decorations;

WHEREAS, the City Treasurer and the City Accountant have certified that there is an available "Beginning/Unappropriated Balance (Surplus from Last Year) amounting to Twenty Five Million Nine Hundred Ninety One Thousand Eight Hundred Sixty Nine Pesos and 77/100 (₱25,991,869.77) that can be utilized for the aforementioned supplemental budget;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled, that:

SECTION 1. The Supplemental Budget No. 2 for Calendar Year 2016 of the Marikina Sports Park, in the amount of Twenty Five Million Nine Hundred Ninety One Thousand Eight Hundred Sixty Nine Pesos and 77/100 (₱25,991,869.77), is hereby approved, provided that the amount appropriated herein must be spent solely for the intended purpose and the disbursement thereof shall be strictly in conformity with existing rules and regulations.

SECTION 2. The herein appropriated amount shall be utilized as follows:
