ORDINANCE AMENDING ORDINANCE 26, SERIES OF 2016 GRANTING BIRTHDAY CASH GIFT TO SENIORS CITIZENS RESIDING IN THE CITY OF MARIKINA AND APPROPRIATING FUNDS THEREFOR

WHEREAS, the City Government of Marikina, in compliance with the objectives of the Expanded Senior Citizens Act of 2010 (R.A. 9994 which amended R.A. 7432 and R.A. 9257) has adopted several measures whereby our senior citizens are assisted and appreciated by the community as a whole;

WHEREAS, among such measures legislated by City Government thru its City Council was the grant of birthday cash gift to elderly thru Ordinance No. 26, Series of 2016;

WHEREAS, said ordinance was passed without providing for its appropriation nor a funding source;

WHEREAS, at its present form, the Ordinance however, could not be effected without the needed budget appropriation as required under the Local Government Code, Section 458(a)(5)(x) which states:

(a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinance, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the City provided for in Section 22 of this Code, and shall:

(5) Approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided under section 17 of this Code, and in addition to said services and facilities, shall: x x x

WHEREAS, a financial review of the budgetary requirement for the cash gift as provided for in Ordinance No. 26 and with consideration of the 2016 General Fund of the City showed the lack of available funds that can be allocated for the purpose, thus precluding the implementation of the subject Ordinance;

WHEREAS, the amount of One Thousand Pesos (P1,000) is a feasible sum to provide for the benefit of cash gift for all senior-residents of the City; in addition to the budget appropriation for the other programs of the City catering for the care and welfare of its elderly citizens.

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF MARIKINA, IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. Section 5 of Ordinance 26, Series of 2016 is hereby amended to read as follows:

“SECTION 5. BIRTHDAY GIFT – This Ordinance will grant One Thousand Pesos (PHP1,000) to all bonafide Senior Citizens in Marikina City during the occasion of their birthdays.”

SECTION 2. Section 6 of Ordinance 26, Series of 2016 is hereby amended to read as follows:

“SECTION 6. BUDGETARY ALLOCATIONS. – The amount necessary to implement this Ordinance shall be appropriated in the annual budget of 2017 and the succeeding years.”

SECTION 3. Section 10 of Ordinance 26, Series of 2016 is hereby amended to read as follows:

“Section 10. EFFECTIVITY – This Ordinance shall take effect in January 2017.”

SECTION 4. Implementing Guidelines. - The Senior Citizens’ Affairs Office and the Office of the City Treasurer shall formulate rules and regulations for the proper implementation of this Ordinance.


