**ORDINANCE No. 050**  
**Series of 2016**

**ORDINANCE AMENDING SECTION 12 OF ORDINANCE NO. 11, SERIES OF 2014 ENTITLED, "ORDINANCE ADOPTING THE REVISED MARKET CODE OF 2014"**

**WHEREAS**, Section 12 of Ordinance No. 11, Series of 2014 requires all vendors and helpers of private and public markets in Marikina City to wear Market Identification Cards for the purpose of monitoring all licensed vendors and helpers and ensuring the safety and protection of both the workers and the market goers;

**WHEREAS**, Section 12 (c) of the same Ordinance provides for the cost of Market Identification Card in the amount of Seventy Five Pesos (₱75.00) payable to the Office of the City Treasury; -



**WHEREAS**, the requirement of wearing Market Identification Cards in all private and public markets in the City was originally provided for under Ordinance No. 087, Series of 2002 and was amended and further amended by Ordinance No. 139, Series of 2002, Ordinance No. 125, Series of 2004, and Ordinance No. 104, Series of 2007;

**WHEREAS**, the City Market Administrator proposed an increase in the cost of Market I.D. since there is an increase in the price of materials being utilized for its production;

**WHEREAS**, since the cost of the Market I.D. will be increased to ₱100.00, there is a need to increase the penalty from ₱100.00 to ₱500.00;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, that:

**SECTION 1.** Section 12 (c) of Ordinance No. 11, Series of 2014 is hereby amended to read as:

*“c) The cost of the Market I.D. is One Hundred Pesos (₱100.00), payable to the Office of the City Treasury.”*

**SECTION 2.** Item (d) is hereby inserted in Section 12 of the same Ordinance which shall read as:

“d) Market ID’s must be worn at all times during vending hours. Penalties for not wearing Market IDs shall be as follows:

First Offense	- Strict admonition
Second & subsequent Offenses	- ₱200.00 fine

**SECTION 3.** Ordinance Nos. 087 and 139, Series of 2002, Ordinance No. 125, Series of 2004, Ordinance No. 104, Series of 2007 and Ordinance No. 11, Series of 2014 are hereby amended accordingly.


**SECTION 4.** This Ordinance shall take effect upon approval.
