**ORDINANCE AMENDING ORDINANCE NO. 64, SERIES OF 2011 ENTITLED,
"ORDINANCE AUTHORIZING THE OFFICE OF THE MARIKINA PUBLIC
MARKET TO COLLECT COLD STORAGE FEES FOR THE USE OF THE
COLD STORAGE FACILITY IN THE MARIKINA PUBLIC MARKET"**

WHEREAS, Ordinance No. 64, Series 2011 was enacted by the City Council on November 9, 2011 which granted authority to the Marikina Public Market Office to collect the amount of Two Pesos (₱2.00)/day for every one (1) kilo of meat, fish and chicken that will be stored in the cold storage facilities of the Marikina Public Market;

WHEREAS, since the enactment of said Ordinance, charges in electricity have already been increased a number of times, thus, the necessity to increase the cold storage fee being collected by the City Market Office;

WHEREAS, the increase in collection of cold storage fee will still entail savings on the part of the market vendors as compared to the utilization of their own freezers or ice containers/boxes;

WHEREAS, Section 458 (a) paragraph (3) (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that:

- (i) *Fix and impose reasonable fees and charges for all services rendered by the city government to private persons or entities; x x*

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the **SANGGUNIANG PANLUNGSOD** of **MARIKINA**, in session duly assembled, that:

SECTION 1. Section 1 of Ordinance No. 64, Series of 2011 is hereby amended to read as follows:

“SECTION 1. The City Government of Marikina hereby authorizes the Office of the Marikina Public Market to collect the amount of Four Pesos (₱4.00) PER DAY for every One (1) Kilo of meat, fish and chicken that will be stored in the cold storage facilities of the Marikina Public Market.”


SECTION 2. This Ordinance shall take effect upon approval.
