ORDINANCE RE-ORGANIZING AND INSTITUTIONALIZING THE MARIKINA CITY ANTI-DRUG ABUSE COUNCIL AND FOR OTHER PURPOSES

WHEREAS, it is inherent upon every local government unit to pursue undertakings to improve public morals and maintain peace and order among equally significant functions mandated through Section 16 of the Local Government Code of 1991;

WHEREAS, in support of the efforts of the national government from preventing the Philippines from becoming a narco-state is highly commendable and achievable;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum No. 98-227 dated December 2, 1998, creating the provincial, city, municipal and barangay anti-drug abuse councils;

WHEREAS, to strengthen and sustain the advocacy campaign against illegal drugs, there is hereby a need to re-organize and institutionalize government's efforts toward this end and properly implement strategies and approaches in handling drug influenced persons;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session, duly assembled that:

Section 1. This Ordinance hereby re-organize and institutionalize the Marikina Anti-Drug Abuse Council (MADAC)

Section 2. The Marikina Anti- Drug Abuse Council shall be composed of the following:

Chairman : The City Mayor
Vice-chairman and Action Officer : The Chairman of the Sanggunian
Committee on Dangerous Drugs

Members:

The Chairman of the Sanggunian Committee on Health and Sanitation
The Chairman of the Sanggunian Committee on Peace and Order
The Chief of Social Welfare and Development Office
The President of Liga ng mga Barangay
The Chief of Anti-Illegal Drugs Special Operations Task Group, PNP-Marikina
The City Director of DILG-Marikina
The City Prosecutor
The DEP-ED-Marikina District Supervisor
The City Health Officer
The NGO-Socio Economic Group Representative
The Church Group Representative
The President of the Kapisanan ng mga Barangay Kagawads (KABAKA)

Section 3. Duties and Responsibilities of the Council:


1. Serve as focal point through which various organizations and individuals can work together
2. Conduct continuing seminars, conferences, or fora and provide information materials on current developments on dangerous drugs and other control measures
3. Serves as a forum for the discussion of various issues, problems and concerns related to drug abuse prevention and rehabilitation
4. Conduct studies, monitor and evaluate programs on drug prevention, control and enforcement
5. Recommend to the City Mayor sustainable programs and new approaches for drug abuse prevention, control and enforcement

Section 4. This Ordinance hereby repeals Ordinance No. 011, Series of 2010 and other resolutions or circulars consistent herewith. ✓


Section 5. This Ordinance takes effect upon its approval.
