**ORDINANCE AMENDING ORDINANCE NO. 003, SERIES OF 2014 OTHERWISE KNOWN AS AN "ORDINANCE PROVIDING "FINANCIAL ASSISTANCE" TO MEMBERS OF THE MARIKINA CITY POLICE STATION FOR ATTENDING TO THEIR COURT DUTIES AND APPROPRIATING FUNDS FOR THE PURPOSE"**

**WHEREAS**, Ordinance No. 003, Series of 2014 was enacted by the 7<sup>th</sup> City Council of Marikina on January 22, 2014 for the purpose of assisting the police operatives in the expenses that are being entailed in judicial proceedings that they attend;

WHEREAS, Section 1 of the aforementioned Ordinance states that:

*“SECTION 1. Any police personnel from the Marikina City Police Station who shall appear before a judicial court in Marikina City to stand as government witness relative to cases filed for violation of the anti-illegal drugs laws shall be entitled to a ₱500.00 financial assistance upon presentation of his/her Certificate of Appearance signed by the concerned Clerk of Court to the City Treasurer’s Office. Former Marikina City Police Station Members who were transferred to different places of assignment but are still attending court duties in Marikina City are still covered by this Ordinance.”*

**WHEREAS**, however, there is a need to give limitations to the grant of “Financial Assistance” so that it will not be abused by the beneficiaries;

**NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA**, in session duly assembled, that:

SECTION 1. Section 1 of Ordinance No. 003, Series of 2014 is hereby amended to read as follows:

*“SECTION 1. Any police personnel from the Marikina City Police Station who shall appear before a judicial court in Marikina City to stand as government witness relative to cases filed for violation of the anti-illegal drugs laws shall be entitled to a ₱500.00 financial assistance upon presentation of his/her Certificate of Appearance signed by the concerned Clerk of Court to the City Treasurer’s Office. However, such financial assistance shall not be granted under the following grounds and circumstances during the specific date and time for hearing:*

- a. *Non-appearance of the police witness;*
- b. *Dilatory motions for postponement made by the police witness;*  
*and*
- c. *If the police personnel is the plaintiff or defendant.*



*Relative hereto, the Certificate of Appearance to be issued by the Clerk of Court to the concerned police personnel shall indicate the grounds and circumstances surrounding the hearing of the case he/she attended as basis for the granting of the financial assistance.*

*Former Marikina City Police Station Members who were transferred to different places of assignment but are still attending court duties in Marikina City are still covered by this Ordinance."*

SECTION 2. This Ordinance shall take effect upon its approval.


