ORDINANCE TO UNDERTAKE THE INSTALLATION OF ADDITIONAL TEN (10) STREETLIGHTS TO BE INSTALLED AT DIFFERENT POSTS LOCATED ALONG MACAPAGAL, MANTI AND DESERET STREETS, VISTA VALLEY EXECUTIVE VILLAGE, BARANGAY STO. NIÑO, MARIKINA CITY AND APPROPRIATING THE AMOUNT OF SIXTY FOUR THOUSAND THREE HUNDRED SEVENTY THREE PESOS AND 76/100 (₱64,373.76) FOR THE ANNUAL ELECTRICAL CONSUMPTION THEREOF

WHEREAS, the installation of adequate lighting in communities, subdivisions and thoroughfares in the City have been given priority by the city government as a deterrent to commission of crimes and the occurrence of untoward incidents;

WHEREAS, the City Engineering Department has conducted an ocular inspection in the areas subject of this Ordinance and recommended to the City Council the immediate installation of additional ten (10) streetlights thereat;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the **CITY COUNCIL OF MARIKINA**, in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby approves the installation of ten (10) street lights at Macapagal, Manti and Deseret Streets, Vista Valley Executive Village, Barangay Sto. Niño, Marikina City.

SECTION 2. The amount of Sixty Four Thousand Three Hundred Seventy Three Pesos and Seventy Six Centavos (₱64,373.76) shall be appropriated annually for the payment of the electrical consumption, chargeable against the funds for "Power, Water and Illumination".


SECTION 3. This Ordinance shall take effect upon its approval.
