ORDINANCE APPROVING THE UTILIZATION OF THE SEVENTY PERCENT (70%) OF THE FIVE PERCENT (5%) ALLOTTED LOCAL RISK REDUCTION AND MANAGEMENT FUND OF THE DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL FOR CALENDAR YEAR 2016 IN THE AMOUNT OF SIXTY FIVE MILLION ONE HUNDRED FORTY THOUSAND NINE HUNDRED THIRTY NINE PESOS AND TWENTY ONE CENTAVOS (PHP 65,140,939.21).

WHEREAS, Executive Order No. 004, Series of 2012 created the Disaster Risk Reduction and Management Council which is tasked with the responsibility of identifying needs and would-be problems arising from calamities and disasters;

WHEREAS, on February 19, 2016 the said Council conducted a meeting to discuss the utilization of the seventy percent (70%) of the five percent (5%) of the allotted Local Risk Reduction and Management Fund for Calendar Year 2016 amounting to Sixty Five Million One Hundred Forty Thousand Nine Hundred Thirty Nine Pesos and Twenty One Centavos (Php 65,140,939.21);

WHEREAS, the Council identified the various needs, tools, materials and other disaster-related equipment that must be procured as necessity during the onslaught of calamities or disasters and thereby cushioning the impact of their dreadful effects;

WHEREAS, the Disaster Risk Reduction and Management Council passed Resolution No.01, Series of 2016 to utilize the above-mentioned amount to enhance the disaster-preparedness and response-capabilities of the City and to mitigate the socio-economic and environmental impact of disasters including climate change;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the CITY COUNCIL of MARIKINA in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby approves the utilization of the Seventy Percent (70%) of the Five Percent (5%) allotted Local Risk Reduction and Management Fund of the Disaster Risk Reduction and Management Council for Calendar Year 2016 in the amount of Sixty Five Million One Hundred Forty Thousand Nine Hundred Thirty Nine Pesos and Twenty One Centavos (Php 65,140,939.21);

SECTION 2. All purchases and procurements in relation to the Local Risk Reduction and Management Fund shall be subjected to the usual bidding processes, accounting and auditing rules and procedures.

SECTION 3. This Ordinance shall take effect upon its approval.




