**ORDINANCE TO UNDERTAKE THE INSTALLATION OF THREE (3) STREETLIGHTS AT POST NO. L10-1546, L10-1388 (M-746370C), SPSR-2-80, 9-35 (114BAG121136) LOCATED AT SUDSOD, PAOD AND KARETA STREETS, BARANGAY STO. NIÑO, MARIKINA CITY AND APPROPRIATING THE AMOUNT OF SEVENTEEN THOUSAND FIVE HUNDRED FIFTY SIX PESOS AND 48/100 (₱17,556.48) FOR THE ANNUAL ELECTRICAL CONSUMPTION THEREOF**

**WHEREAS**, the installation of adequate lighting in communities, subdivisions and thoroughfares in the City have been given priority by the city government as a deterrent to commission of crimes and the occurrence of untoward incidents;

**WHEREAS**, the City Engineering Department has conducted an ocular inspection in the areas subject of this Ordinance and recommended to the City Council the immediate installation of streetlights thereat;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED** by the **CITY COUNCIL OF MARIKINA**, in session duly assembled, that:

**SECTION 1.** The City Government of Marikina hereby approves the installation of three (3) street lights at Post No. L10-1546, L10-1388 (M-746370C), SPSR-2-80, 9-35 (114bag121136) located at Sudsod, Paod and Kareta Streets, Barangay Sto. Niño, Marikina City.

**SECTION 2.** The amount of Seventeen Thousand Five Hundred Fifty Six Pesos and Forty Eight Centavos (₱17,556.48) shall be appropriated annually for the payment of the electrical consumption, chargeable against the funds for "Power, Water and Illumination".


**SECTION 3.** This Ordinance shall take effect upon its approval.


