ORDINANCE EXTENDING THE PERIOD FOR THE RENEWAL OF BUSINESS PERMITS FROM JANUARY 21 TO JANUARY 31, 2017 WITHOUT SURCHARGES AND PENALTIES

WHEREAS, the recent programs of the present administration under the efficient leadership of the City Mayor, Honorable Marcelino R. Teodoro has encouraged businessmen in Marikina City to put up businesses and for existing business owners to renew the registration of their business permits;

WHEREAS, as a result, the Business Permits and Licensing Office (BPLO) has been receiving numerous business permits registration and renewal, thus the need to extend the duration for the renewal of business permits;

WHEREAS, Section 167 of the Local Government Code of 1991 provides that:

“SECTION 167. Time of Payment. – Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months.”

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby extends the renewal of Business Permits from January 21 to January 31, 2017 without surcharges and penalties due to the increase in the number of business permits renewal.


SECTION 2. This Ordinance shall take effect upon approval.
