**WHEREAS**, on April 14, 2016 the 7<sup>th</sup> City Council adopted Resolution No. 056 Series of 2016 entitled *Resolution Authorizing The City Mayor, Honorable Del R. De Guzman, To Enter Into And Sign A Memorandum of Agreement Between The City Government of Marikina, The Department of Education, Department of Trade and Industry, Department of Labor and Employment, Technical Education and Skills Development Authority, Department of Social Welfare and Development, Department of Health, and the Department of Agriculture for the Implementation of the 2016 Local Poverty Reduction Action Plan of the City;*

**WHEREAS**, the 8<sup>th</sup> City Council was in receipt of a copy, thru Vice Mayor Jose Fabian I. Cadiz, M.D., of a letter of Mr. Ernesto Alcantara, PCCI-New Marikina President, requesting, among other things, for the amendment of the aforesaid resolution and in effect substitute the name of former Mayor Del R. De Guzman with the name of incumbent Mayor Marcelino R. Teodoro in the Memorandum of Agreement that was entered into by and between the City Government of Marikina and concerned national agencies;

**WHEREAS**, the Committee on Rules to which the matter was referred agreed that the same agreement is still legally binding and enforceable and said that it would be inappropriate and, in fact unlawful, for the City Government of Marikina to enter into another memorandum of agreement with Mayor Teodoro signing his name therein;

**WHEREAS**, the same committee recommends that a separate and distinct Resolution be adopted authorizing the incumbent Mayor Marcelino R. Teodoro to negotiate, transact, sign and execute all documents necessary to implement the existing and current Memorandum of Agreement.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD** to authorize as it hereby authorizes the Hon. Mayor Marcelino R. Teodoro to negotiate, transact, sign and execute all documents necessary to implement the existing and current Memorandum of Agreement that was entered into by and between the City Government of Marikina and the Department of Education, Department of Trade and Industry, Department of Labor and Employment, Technical Education and Skills Development Authority, Department of Social Welfare and Development, Department of Health,


**RESOLVED FURTHER** to furnish copy of this Resolution to the Honorable City Mayor Marcelino R. Teodoro for his information and appropriate action.
