RESOLUTION DECLARING BARANGAY APPROPRIATION ORDINANCE NO. 01, SERIES OF 2016 OF BARANGAY BARANGKA, THIS CITY, CONTAINING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2016 IN THE AMOUNT OF SEVEN MILLION THREE HUNDRED SIXTY SEVEN THOUSAND TWO HUNDRED SEVENTY SIX PESOS AND TWENTY FIVE CENTAVOS (₱7,367,276.25), TO BE CONSISTENT WITH LAW

WHEREAS, preliminary review was undertaken by the City Budget Office and was endorsed to the Sangguniang Panlungsod for its final review and approval;

WHEREAS, upon review, it shows substantial compliance with the provisions of the Local Government Code of 1991, implementing circulars and other issuances and compliance therewith shall be the responsibility of the Barangay;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled to declare Barangay Appropriation Ordinance No. 01, Series of 2016 of Barangay Barangka, this City, containing the Supplemental Budget No. 1 for C.Y. 2016 in the amount of Seven Million Three Hundred Sixty Seven Thousand Two Hundred Seventy Six Pesos and 25/00 (₱7,367,276.25), to be consistent with law.




