**WHEREAS**, Bishop Francisco Mendoza De Leon, D.D. as Co-Adjutor of the Diocese of Antipolo has the right to succeed the retiring bishop thus preventing the occurrence of "*sede vacante*;"

**WHEREAS**, prior to this, Bishop Francisco Mendoza De Leon, D.D. was ordained priest 41 years ago to the Episcopacy by the late Manila Archbishop Jaime Lachica Sin;

**WHEREAS**, on June 27, 2007, Pope Benedict XVI appointed him Auxiliary Bishop of Antipolo and Titular Bishop of *Boseta* and was consecrated bishop on September 1, 2007 by Gaudencio Borbon Rosales, then Cardinal of Manila;

**WHEREAS**, on November 22, 2015, Pope Francis after serving for almost 8 years as Auxiliary Bishop, Bishop Francisco Mendoza De Leon, D.D. was appointed as the New Co-adjutor Bishop of Antipolo;

**WHEREAS**, the members of the 8<sup>th</sup> City Council of Marikina join the Honorable City Mayor Marcelino R. Teodoro in wishing His Excellency the Most Reverend Francisco Mendoza De Leon, D.D. all the best in his new assignment especially in molding the spiritual growth of his flock;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA** in session duly assembled, to extend warmest congratulations to His Excellency, the Most Reverend Francisco Mendoza De Leon, D.D., on his canonical possession of the seat of the Diocese of Antipolo as its new Bishop;




