**RESOLUTION ADOPTING THE EXISTING INTERNAL RULES OF  
PROCEDURE FOR THE 8<sup>TH</sup> CITY COUNCIL OF MARIKINA**

**WHEREAS**, the *Sangguniang Panlungsod* of Marikina is a legislative body duly organized pursuant to law for the enactment of ordinances and the adoption of resolutions for the governance of the city;

**WHEREAS**, pursuant to and in accordance with the provisions of Sec. 50, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local *Sanggunian* bodies shall adopt or update the existing rules of procedures for the proper discharge of legislative functions;

**WHEREAS**, in the maintenance of good order in the City Council's deliberations, it is necessary that specific rules be adopted and enforced in the interest of effective legislation;

**WHEREAS**, the *Sangguniang Panlungsod* of Marikina has an existing Rules of Procedure under Resolution No. 08-2015 which can be revised, updated as the Internal Rules of Procedure of the 8<sup>th</sup> City Council;

**WHEREAS**, the members of the 8<sup>th</sup> City Council opted to adopt *en toto* the existing rules of procedure without prejudice to revising or updating the same within ninety (90) days following the election of the members pursuant to Section 50 of the Code;


