**WHEREAS**, the City Government of Marikina thru the City Council is formulating plans and ideas to adopt measures enhancing the way of life of Persons with Disabilities (PWD) and Senior Citizens of the City;

**WHEREAS**, the Honorable City Vice-Mayor Jose Fabian I. Cadiz, M. D., initiated the production of a customized vehicle likewise known as "*Adaptive Mobile Vehicle (AMV)*" which is made especially for the PWDs and Senior Citizens designed for their easy and convenient transportation;

**WHEREAS**, His Excellency, Former President Ferdinand E. Marcos signed into law on February 25, 1983, Republic Act No. 344 known as the "*Accessibility Law*" which is "*An Act to Enhance the Mobility of Disabled Persons by Requiring Certain Buildings, Institutions, Establishments, Public Utilities, Facilities and other Devices*";

**WHEREAS**, Republic Act No. 9994 shares the same idea known as: "*An Act Granting Additional Benefits and Privileges to Senior Citizens, Further Amending Republic Act No. 7432, as Amended otherwise known as: "An Act to Maximize the Contribution of Senior Citizens to Nation Building, Grant Benefits and Special Privileges and for other purposes Particularly in the Effort to Adopt Measures Whereby the Senior Citizens are assisted and to Give Full Support to the Improvement of their Well-Being"*";

**WHEREAS**, Book III Chapter I Section 384 of the 1991 Local Government Code provides:

*" x x x Role of Barangay – As the basic political unit, the barangay serves as the primary planning and implementing unit of the government policies, plans, programs, projects and activities in the community and as a forum wherein the collective views of the people may be expressed, crystallized and considered x xx "*

**WHEREAS**, Barangay units in the city are hereby encouraged to allocate funds for the production of the Adaptive Mobile Vehicle for the PWDs and Senior Citizens which can also be used as emergency response vehicles;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the CITY COUNCIL OF MARIKINA in session duly assembled, to encourage barangay governments in

the city to provide customized vehicles (Adaptive Mobile Vehicle) for persons with disabilities and senior citizens.


**RESOLVED FINALLY**, that copy of this resolution be furnished to all concerned for their information and appropriate action.
