RESOLUTION GRANTING EXEMPTION TO MS. LAUREEN JALIJALI-JUE FROM THE REQUIRED THREE-METER SETBACK ON HER RESIDENTIAL STRUCTURE LOCATED AT No. 5 MT. VERNON STREET, NEW MARIKINA SUBDIVISION, BARANGAY STA. ELENA, MARIKINA CITY

WHEREAS, in her letter dated June 18, 2015, Ms. Laureen Jalijali-Jue has appealed again for an exemption from the required three-meter setback on her residential structure located at No. 5 Mt. Vernon Street, New Marikina Subdivision, Barangay Sta. Elena, Marikina City, her appeal for consideration goes as far back as February 12, 2012;

WHEREAS, due to her fear because of experience during Typhoon Ondoy, Ms. Jue immediately planned to reconstruct by adding a 3rd floor to serve as their family's refuge during emergencies and disasters;

WHEREAS, Ms. Jue have already tried other options in cooperation with the Engineering Department and that demolishing the ground floor portion of the house would be too costly and could compromise the integrity of the building;




