WHEREAS, the Land Bank of the Philippines (LBP) is a government-owned and controlled corporation created under R.A. 3844, as amended:

WHEREAS, the Land Bank of the Philippines – Marikina Branch, represented by its Branch Manager, Ms. Rina E. Oscillada, has expressed its willingness to install an offsite Automated Teller Machine (ATM) unit at the premises of the New Legislative Building;

WHEREAS, LBP shall shoulder the cost for the renovation of the space that will be allotted to the ATM unit and will shoulder the payment for the data line/communication line expenses that will be connected to the machine while the City Government will shoulder the cost of electric bills;

WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in a Memorandum of Agreement (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Memorandum of Agreement between the City Government of Marikina and the Land Bank of the Philippines represented herein by the LBP Marikina Branch Manager, Ms. Rina E. Oscillada, for the installation of an ATM unit at the Ground Floor of the Legislative Building.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, the Land Bank of the Philippines – Marikina Branch, and other concerned offices for their information and appropriate action.


