*“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”*

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman to enter into and sign a Contract of Affiliation with the International Institute of Sterile Management Services, Inc.


