WHEREAS, Chapter III, Section 33 of the Local Government Code of 1991 provides:

" xxx Cooperative Undertakings Among Local Government Units. – Local government units may, through appropriate ordinances, group themselves, consolidate or coordinate their efforts, services and resources for purposes commonly beneficial for them. x xx ";

WHEREAS, on December 7, 2015, the Municipal Council of Sabtang, Province of Batanes adopted Resolution No. 050 Series of 2015 entitled: "A Resolution Requesting a Sisterhood LGU Relationship with the City of Marikina and thereby Authorizing the Municipal Mayor Hon. Maxilindo Emilio A. Babalo to Enter into a MOA for the purpose";

WHEREAS, the primary purpose of the resolution is to share/exchange knowledge in technology, tourism, culture and arts, planning and development, commerce, trade and industry, youth education and sports, environmental protection public health and social services as stated in the above cited resolution;

WHEREAS, the City of Marikina welcomes this humble gesture to establish bilateral cooperation through the adoption of common programs on the above-mentioned fields;

WHEREAS, Chapter III, Article I, Section 455, vi of the Local Government Code of 1991 further provides:

" xxx Represent the city in all its business transactions and sign in its behalf x xx and such other documents upon authority of the SangguniangPanlungsod or pursuant to law or ordinance x xx"

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the CITY COUNCIL OF MARIKINA in session duly assembled, to establish sisterhood ties between the Municipality of Sabtang, Province of Batanes and the City of Marikina; thereby authorizing the Honorable City Mayor Del R. De Guzman to sign a Memorandum of Agreement for the said purpose.

RESOLVED FINALLY, that copy of this resolution be furnished to all concerned for their information and appropriate action.
