WHEREAS, the Barangay Council of Sta. Elena enacted Barangay Appropriation Ordinance No. 03 Series of 2015 pertaining to its Annual Budget in the amount of Eight Million One Hundred Forty Eight Thousand Three Hundred Ninety Two Pesos (8,148,392.00);

WHEREAS, the Treasurer of the said Barangay duly certified the existence of the amount subject of the Annual Budget;

WHEREAS, the same was reviewed by the City Budget Office and was endorsed by the City Administrator to the City Council for its review and approval;

WHEREAS, Article III, Section 458 (a), (1), (i) of the Local Government Code of 1991 provides:


“ x x x The Sangguniang Panlungsod, as the legislative body of the city shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants x x x Approve ordinances and pass resolutions necessary for the efficient and effective city government x x x Review all ordinances approved by the sangguniang barangay x x x to determine whether these are within the scope of the prescribed powers of the sanggunian x x x “

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **CITY COUNCIL OF MARIKINA** in session duly assembled to declare Barangay Appropriation Ordinance No. 03 Series of 2015 of Barangay Sta. Elena pertaining to its Annual Budget in the amount of Eight Million One Hundred Forty Eight Thousand Three Hundred Ninety Two Pesos (8,148,392.00) to be consistent with the law.


RESOLVED FINALLY, that copy of this Resolution be furnished to concerned Offices and Agencies for their information and appropriate action.


