**WHEREAS**, the comprehensive traffic program should include re-training of traffic enforcers as well as strict implementation of rules on street diggings and elimination of road obstructions, among others;

**NOW, THEREFORE, BE IT RESOLVED** to enjoin as it hereby enjoins the City Transportation Management and Development Office, Marikina City Philippine National Police and other traffic law enforcement agencies to come up with a comprehensive traffic program and traffic reduction strategies in order to solve bottlenecks in the major streets in Marikina City;


