**WHEREAS**, Section 16. General Welfare of the Local Government Code of 1991 provides that:

*“ x x x Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental to the promotion of the general welfare of its citizens x x x”;*

**WHEREAS**, in recognition and appreciation, and to further enhance their dedication and commitment in voluntary service, the City Government deems it necessary to provide them with PhilHealth Insurance.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNSOD OF MARIKINA**, in session duly assembled to request the City Government of Marikina through the Honorable Mayor Del R. De Guzman to include all qualified Bantay Bayan and Barangay Peacekeeping Action Team (BPAT) in the provision of PHILHEALTH Insurance under the Local Government Sponsorship.

**RESOLVED FURTHER**, that copies of this resolution be furnished to Honorable Mayor Del R. De Guzman, Office of the Social Welfare and Development and all concerned offices of the City Government.


