WHEREAS, the riprap segment along Mirasol Street, Barangay Nangka, this City, was noticeably damaged caused by heavy rains and strong winds brought by typhoons on September 4, 2016;

WHEREAS, upon inspection, the substantial part of the riprap showed tension cracks and it is now obviously sinking following the damage done to 57 houses located near the unstable area;

WHEREAS, if no immediate measures are implemented, coupled with tremors, intense flooding and continuous rains, the riprap might eventually collapse to the detriment of the residents living thereat;

WHEREAS, the repair of such riprap segment requires a huge capital outlay which the City Government, because of its limited resources, cannot yet provide;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE MEMBERS OF THE SANGGUNIANG PANLUNGSOD OF MARIKINA in session assembled to request as it hereby respectfully requests the Honorable Romero Federico S. Quimbo, Congressman of the 2nd Legislative District of Marikina City, to extend financial assistance to fund the immediate repair/rehabilitation of the riprap segment along Mirasol Street, Barangay Nangka, this City;


RESOLVED FURTHER that copy of this Resolution be furnished to the Honorable Congressman Romero Federico S. Quimbo, for his consideration and approval;


