WHEREAS, the residents of San Miguel Phase 1, 2, 3, 4 and Victory Hills in Barangay Fortune, requested for the installation of at least Ten (10) park lights along Nangka River at the back of houses of the said areas;

WHEREAS, the City Government of Marikina is cognizant that sufficient street lightning is vital in the creation of safe and progressive communities;

NOW THEREFORE BE IT RESOLVED, AS IT HEREBY RESOLVED BY THE SANGGUINANG PANLUNGSOD of MARIKINA in session assembled to request the city government of Marikina through its Engineering Department to install at least ten (10) park lights along Nangka River at the back of San Miguel Phase 1, 2, 3, 4 and Victory Hills, Barangay Fortune, this City;

RESOLVED FURTHER, that funds for this purpose shall be allotted from the 2016 Annual Executive Budget of the City Government of Marikina;


RESOLVED FINALLY, that the copy of this Resolution be furnished the City Engineering Department, for appropriate action.
