RESOLUTION DECLARING BARANGAY ORDINANCE NO. 2015-019 SERIES OF 2015 OF BARANGAY MARIKINA HEIGHTS, THIS CITY ENTITLED "ORDINANCE UTILIZING THE 70% DISASTER PREPAREDNESS AND 30% QUICK RESPONSE OF THE 5% CALAMITY FUND FROM THE ANNUAL BUDGET CALENDAR YEAR 2016 OF BARANGAY COUNCIL OF MARIKINA HEIGHTS IN THE AMOUNT OF ONE MILLION TWENTY FIVE THOUSAND PESOS (PHP 1,025,000.00)" TO BE CONSISTENT WITH LAW.

WHEREAS, the City Council reviewed the abovementioned Barangay Ordinance and finds it in accordance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA , IN SESSION DULY ASSEMBLED, to declare Barangay Ordinance No. 2015-019 Series of 2015 of Barangay Marikina Heights, this City entitled: "Ordinance Utilizing the 70% Disaster Preparedness and 30% Quick Response of the 5% Calamity Fund from the Annual Budget Calendar Year 2016 of Barangay Council of Marikina Heights in the amount of One Million Twenty Five Thousand Pesos (Php 1,025,000.00)" to be consistent with law.


