**WHEREAS**, Danny Florencio, a bona fide Marikeno, *“became a member of the RP Team that finished second in the 1971 ABC Championships in Tokyo, which earned them a berth in the 1972 Munich Olympics... and he was also part of the national team that won gold in 1967 ABC Championship and earned the berth for the 1968 Summer Olympics in Mexico;”*

**WHEREAS**, *on November 5, 1977, he became the first local player in the PBA to score more than 60 points in a game... and at the end of his career, he ranked 11th in the all-time scoring plateau with 5,791 points, eighth in scoring average, and 13th all time in steals;”*

**WHEREAS**, Danny Florencio, known as the original Skywalker, is recognized as one of the 25 Philippine Basketball Association (PBA) Greatest Players, a rare group of exceptional basketball players, and thereafter was inducted into PBA Hall of Fame in 2007;

**WHEREAS**, with all his triumphs as a well-accomplished athlete, Danny Florencio deserves recognition for his tremendous athletic talent and for the honor and distinction he has brought to Marikina City and to the entire country;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA**, in session duly assembled to honor and congratulate Danilo “Danny” Zoleta” Florencio who brought enormous goodwill to Marikina City, and to the rest of the country as one of the greatest athletes and Olympians in the history of our nation;


