WHEREAS, Pilipinas 911, Inc. is a private association represented herein by its Managing Director, Mr. Ruel S. Kapunan;

WHEREAS, Pilipinas 911 has the capability to conduct Pre-Hospital Care Trainings for stroke and heart attack patients which must be learned by the Rescue 161 responders so that they would be able to properly care for such patients while on the way to the nearest hospital;

WHEREAS, in exchange of the said training, the Marikina City Disaster Risk Reduction Management Office (MCDRRMO), through its Rescue 161, will be accepting On-the-Job Trainees from Pilipinas 911;


WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in an Agreement of Cooperation (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign the Agreement of Cooperation between the Marikina City Disaster Risk Reduction Management Office and Pilipinas 911, Inc.


