**WHEREAS**, the Department of Education is a national government unit duly organized and existing under the laws of the Republic of the Philippines that is mandated to formulate, implement, and coordinate policies, plans, programs and projects in the areas of formal and non-formal basic education;

**WHEREAS**, the Department of Education-National, the Department of Education, Division of Marikina and the City Government of Marikina is working hand in hand to provide students-athletes with the opportunity to hone their skills as well as provide them with the necessary facilities and qualified trainers;

**WHEREAS**, the City's hosting of the 6<sup>th</sup> Association of South East Asian Nation School Games in November 29 to December 7, 2014 enabled the parties to identify the strengths and areas of improvement of the country's delegate in sports competition;

**WHEREAS**, the terms and conditions which the parties will agree upon shall be embodied in a Memorandum of Agreement (as per attached draft);

**WHEREAS**, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, *the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x* and shall:

*“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”*

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Memorandum of Agreement executed among the City Government of Marikina, the Department of Education represented herein by Br. Armin Luistro, FSC and the Department of Education, Division of Marikina duly represented by Dr. Helen Grace V. Go.

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, the Department of Education, and the Department of Education Division of Marikina, and other concerned offices for their information and appropriate action.


