**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, THE CITY GOVERNMENTS OF PASIG AND MARIKINA TO INVESTIGATE THE DUMPING OF FILLING MATERIALS ALONG THE MARIKINA RIVER SPECIFICALLY IN BARANGAY SANTOLAN, PASIG CITY**

**WHEREAS**, there is an on-going dumping of filling materials along the Marikina River in Barangay Santolan, Pasig City which is allegedly being undertaken by a private corporation;

**WHEREAS**, said dumping of filling materials or encroachment on the length and breadth of the waterway will eventually reduce the river capacity to flush out water during heavy rains;

**WHEREAS**, this will also result to the immediate swelling of the Marikina River during typhoons which will cause alarm and threat to the lives and properties of the Marikina City constituents as well as the neighboring cities and municipalities;

**WHEREAS**, the dumping of filling materials, in addition to heavy downpours as well as the heavy siltation of the river will definitely cause the sudden rise of water level during rainy days;

**WHEREAS**, there is an immediate need for the conduct of an investigation/inspection of the ongoing activity to determine if there is a need to cease the dumping of filling materials in the area;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to request the Department of Public Works and Highways (DPWH), the Department of Environment and Natural Resources (DENR), the City Governments of Pasig and Marikina to investigate the dumping of filling materials along the Marikina River specifically in Barangay Santolan, Pasig City.




