WHEREAS, that on February 16, 2016, at about 6:30 in the evening, the Barangay Tanod and Volunteers of Barangay Sto. Niño headed by Barangay Kagawad Jay Espidillon were patrolling along the jogging lane;

WHEREAS, a concerned citizen approached them and reported that he saw an individual sitting beside the Skating Rink in Marikina River Park while allegedly holding suspected marijuana leaves;

WHEREAS, the Barangay Tanod and Volunteers of Barangay Sto. Niño immediately proceeded to the area and saw in plain view the person who was holding one (1) piece of plastic sachet believed to be containing dried marijuana leaves;

WHEREAS, upon frisking the suspect, the Barangay Enforcers recovered from him eleven (11) sachets of suspected dried marijuana leaves;

WHEREAS, the enforcers immediately conducted an inventory at the scene which was witnessed by Barangay Kagawad Jay Espidillon;

WHEREAS, the suspect and the recovered evidences were brought to the Eastern Police District Crime Laboratory for examination and a case for violation of Article II, Section 11 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002;

WHEREAS, the immediate response of the Barangay Enforcers, Volunteers and Barangay Kagawad Espidillon is an act worthy of praise and emulation;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled, to commend Barangay Tanod Glenrenz Esquilona, Barangay Tanod Reowel Jocson, Barangay Volunteers Luisa Jardin, Audie Cruz, Christian Gabriel and Barangay Kagawad Jay Espidillon of Barangay Sto. Niño, this City for causing the arrest of a suspected drug pusher at the Skating Rink located in Marikina River Park.

RESOLVED FURTHER, that copies of this Resolution be given to Barangay Kagawad Jay Espidillon and the concerned Barangay Enforcers for their information.




