DE GUZMAN, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF MARIKINA, THE DEPARTMENT OF EDUCATION, DEPARTMENT OF TRADE AND INDUSTRY, DEPARTMENT OF LABOR AND EMPLOYMENT, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, DEPARTMENT OF HEALTH, AND THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF THE 2016 LOCAL POVERTY REDUCTION ACTION PLAN OF THE CITY

WHEREAS, on February 17, 2016, the City Government of Marikina adopted Resolution No. 018, Series of 2016 entitled, "Resolution Adopting the 2016 Local Poverty Reduction Action Plan of Marikina City";

WHEREAS, the priority poverty reduction projects will be implemented by the City Government of Marikina with counterpart National Government Agencies such as the Department of Education (DepEd), the Department of Trade and Industry (DTI), the Department of Labor and Employment (DOLE), the Technical Education and Skills Development Authority (TESDA), the Department of Social Welfare and Development (DSWD), the Department of Health (DOH), and the Department of Agriculture (DA);

WHEREAS, relative to the implementation of the projects, the City Government of Marikina will be entering into a Memorandum of Agreement with the aforementioned national government agencies;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, *the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:*

"(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x"

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Memorandum of Agreement with the Department of Education, the Department of Trade and Industry, the Department of Labor and Employment, the Technical Education and Skills Development Authority, the Department of Social Welfare and Development, the Department of Health, and the Department of Agriculture for the implementation of the 2016 Local Poverty Reduction Action Plan of the City.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman and all concerned offices/agencies, for their information and appropriate action.


