**WHEREAS**, the WHO Framework Convention on Tobacco Control (WHO FCTC) was developed in response to the globalization of the tobacco epidemic and is an evidence-based treaty that reaffirms the right of all the people to the highest standard of health. The Convention represents a milestone for the promotion of public health and provides new legal dimensions for international health cooperation;

**WHEREAS**, WHO FCTC has the force and effect of national law pursuant to the doctrine of incorporation enshrined in the Constitution, the Philippine Government as one of the parties to the agreement, having signed and ratified the Convention is thus bound by its treaty obligation to adapt the standards and measures contained therein;

**WHEREAS**, the Metropolitan Manila Development Authority (MMDA) is a partner of the City of Marikina in the implementation of this Resolution through the provision of technical and manpower support in various enforcement and capacity-building activities such as but not limited to apprehension of violators, training of enforcers, communication development workshops, monitoring and evaluation and reporting;

**WHEREAS**, the Metropolitan Manila Development Authority issued Resolution No. 15-20 Series of 2015, entitled "RESOLUTION URGING ALL LOCAL GOVERNMENT UNITS OF METROPOLITAN MANILA TO ENACT ORDINANCES IN ACCORDANCE WITH THE PROVISIONS OF THE WORLD HEALTH ORGANIZATION'S FRAMEWORK CONVENTION ON TOBACCO CONTROL (WHO FCTC)";

**WHEREAS**, RA 7160 otherwise known as the Local Government Code of 1991 mandates the Local Government Units to promote the general welfare of their constituency and enact laws, under local and international laws, which will promote the general welfare and health of their constituents within their respective territorial jurisdictions;

**WHEREAS**, the City Government of Marikina in compliance with the abovementioned resolution of the Metropolitan Manila Development Authority (MMDA) and in accord with the provisions of RA 7160 is hereby adopting the World Health Organization's Framework Convention on Tobacco Control (WHO FCTC) for implementation.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA**, in session duly assembled, to adopt as it hereby adopts the World Health Organization's Framework Convention on Tobacco Control (WHO FCTC) in compliance with the Metropolitan Manila Development Authority Resolution No. 15-20, Series of 2015.




