WHEREAS, on February 22, 2016, Mr. Antonio L. Maramag, Jr. sent a request letter to the City Council requesting for the approval of the plan for his proposed food business located at Barangay Sto. Niño, this City and requesting for exemption from the three (3) meter setback requirement;

WHEREAS, upon review and discussion of the City Technical Committee on Housing, Zoning, Urban Planning and Community Development, it was found out that food business is allowed in the said area which is classified under C-1or Low Density Commercial Zone;

WHEREAS, Mr. Maramag assured the committee that his business will not directly affect the sidewalk, given that he already provided a separate parking area where the clients can park;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **CITY COUNCIL OF MARIKINA**, in session duly assembled, to allow Mr. Antonio L. Maramag, Jr. to utilize his lot located at Lot 69-A Block 100-A-C-6 Nimfa Street corner Guerilla Street, Barangay Sto. Niño, this City for the proposed food business and thereby granting him exemption from the three (3) meter setback requirement.


RESOLVED FINALLY, that copy of this resolution be furnished the concerned for their information and appropriate action.


