WHEREAS, Republic Act No. 8792 (E-Commerce Act of 2000) required government offices and agencies engaged in the acceptance of payments to accept and acknowledge payments, among others, using electronic data messages systems;

WHEREAS, in compliance with the aforementioned law, the Home Development Mutual Fund or Pag-IBIG Fund is implementing Pag-IBIG Fund Circular No. 355 which mandates all government and private employers with at least ten (10) employees to remit membership savings (MS) and loan amortizations through electronic payment and collection facilities (EPCF) of their accredited partner banks;

WHEREAS, all covered employers are required to start utilizing the EPCF not later than July 31, 2016;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to subscribe to the Land Bank of the Philippines' internet payment facility known as "wePayAccess" and to designate the City Treasurer, Ms. Thelma T. Quilingking to enroll in the said payment facility.

RESOLVED FURTHER, to authorize the City Treasurer, Ms. Thelma T. Quilingking, to: (1) execute/sign all documents necessary to subscribe to LBP's "wePayAccess"; (2) designate/authorize personnel to act as "maker" or "authorizer" for the company's access to LBP's wePayAccess internet payment facility; and (3) amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the wePayAccess modules, authorization rules and/or any information on the original and succeeding enrollments.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the City Treasurer, Ms. Thelma T. Quilingking, the Land Bank of the Philippines, and other concerned offices for their information and appropriate action.

UNANIMOUSLY ADOPTED by the **SANGGUNIANG PANLUNGSOD of MARIKINA** this 20th day of April, 2016.


