WHEREAS, the City Government of Marikina, through Ordinance No. 31, Series of 2015 as amended by Ordinance No. 002, Series of 2016 was authorized to avail of a loan term facility from the Philippine Veterans Bank in the amount of Five Hundred Million Pesos (\$\mathbb{P}\$500,000,000.00), to finance the priority projects of the City;

WHEREAS, Ordinance No. 003, Series of 2016 likewise authorized the City to avail of a loan term facility from the same bank in the amount of Two Hundred Twenty Six Million Pesos (\$\mathbb{P}\$226,000,000.00), to finance the construction of the Pamantasan ng Lungsod ng Marikina (PLMar) Phase 2 Project;

WHEREAS, relative to the aforementioned loans, there is a need to open two (2) separate bank accounts to facilitate the proper recording and monitoring of all transactions;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to approve the opening of two (2) Bank Accounts with the Philippine Veterans Bank for the City's Existing ₱500,000,000.00 loan and the upcoming ₱226,000,000.00 loan, thereby authorizing the City Treasurer of Marikina, on behalf of the City Government of Marikina, to open said accounts to facilitate the proper recording and monitoring of all transactions involving the aforementioned loans.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, the City Treasurer, Ms. Thelma T. Quilingking, the Philippine Veterans Bank and other concerned offices for their information and appropriate action.
