RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE DEL R. DE GUZMAN, TO ENTER INTO AND SIGN A MERCHANT AGREEMENT POINT-OF-SALE PAYMENT SYSTEM BETWEEN THE CITY GOVERNMENT OF MARIKINA AND DEVELOPMENT BANK OF THE PHILIPPINES, FOR THE USE OF CREDIT AND DEBIT CARD TRANSACTIONS FOR THE PAYMENT OF LOCAL GOVERNMENT TAXES, FEES AND SERVICES

WHEREAS, the City Council of Marikina enacted Ordinance No. 123, Series of 2008 which allowed the payment of real property taxes and other payments through banks, on-line ATM and Credit Card Payment;

WHEREAS, on November 25, 2015, the City Council likewise adopted Resolution No. 191, Series of 2015, which authorized the City Mayor, Honorable Del R. De Guzman to enter into and sign a Tripartite Memorandum of Agreement between the City Government of Marikina, Bancnet Inc., and the Development Bank of the Philippines for the implementation of the online payment of real property taxes;

WHEREAS, relative to the aforementioned legislations, there is a need for the City Government of Marikina to enter into a Merchant Agreement Point-of-Sale System with the Development Bank of the Philippines for the use of credit and debit card transactions for the payment of local government taxes, fees and services;


WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in a Merchant Agreement Point-of-Sale System (for VISA Credit and Debit Card Transactions) (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x xx and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x xx”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Merchant Agreement Point-of-Sale System between the City Government of Marikina and the Development Bank of the Philippines, herein represented by its Vice President, Ricardo Josef S. Bandal II, for the use of credit and debit card transactions for the payment of local government taxes, fees and services.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, the City Treasurer, Ms. Thelma T. Quilingking, and the Development Bank of the Philippines, through its Vice President, Mr. Ricardo Josef S. Bandal II, for their information and appropriate action.
