**WHEREAS**, the Teach for the Philippines, Inc. is a non-stock, non-profit corporation organized and existing under the laws of the Republic of the Philippines whose vision is to provide the Filipino children access to an excellent and relevant education and advocating functional literacy and progressive teacher and administrator training;

**WHEREAS**, the Department of Education, Division of Marikina is a government agency created and existing by virtue of the laws of the Republic of the Philippine whose mandate is to formulate, implement, and coordinate policies, plans, programs and projects in the areas of formal and non-formal basic education;

**WHEREAS**, it is also mandated to supervise all elementary and secondary education institutions, including alternative learning system, both public and private and provides for the establishment and maintenance of a complete, adequate, and integrated system of basic education relevant to the goals of national development;

**WHEREAS**, the DepEd-Marikina and the City Government of Marikina, recognize the nature of high-need public schools and welcome the implementation of the Teach for the Philippines Program for SY 2016-2017 and SY 2017-2018 which will: (1) provide Fellows in Philippine public schools in Marikina City; (2) continue the program in which education and non-education majors are trained to become successful and transformational teachers; (3) help in the research and development for future education policies based on scientific evidence;

**WHEREAS**, for the coverage of this Memorandum of Agreement, there will be ten (10) Fellows who will be assigned in Nangka Elementary School, Malanday Elementary School and Concepcion Integrated School-Elementary Division;

**WHEREAS**, the terms and conditions which the parties will agree upon shall be embodied in the Memorandum of Agreement (as per attached draft);

**WHEREAS**, Section 455 of the same Code provides that:

*“(b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:*

*(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x x x”*

De Guzman, to enter into and sign a Memorandum of Agreement with the Teach for the Philippines, Inc. and the Department of Education, Division of Marikina.

**RESOLVED FURTHER**, that copies of this resolution be furnished the Office of the City Mayor, the Department of Education, Division of Marikina through its Schools Division Superintendent Dr. Helen Grace Go, Teach for the Philippines, Inc., through its Chief Executive Officer, Ms. Clarissa Isabelle L. Delgado and other concerned offices/agencies for their information and appropriate action.
