WHEREAS, on April 13, 2016 the 7th City Council of Marikina unanimously adopted Resolution No. 058 Series of 2016 which allows Mr. Antonio L. Maramag, Jr. to utilize his lot located at Lot 69-A Block 100-A-C-6 Nimfa Street corner Guerilla Street, Brgy. Sto. Niño, this City for the proposed food business and thereby granting him exemption from the three meter setback requirement;

WHEREAS, however, Mr. Maramag should be granted exemption from the five (5) meter setback requirement and not only three (3) meters considering that the purpose of exemption is for business, thus this amendment;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA in session duly assembled, to amend the title of Resolution No. 058 Series of 2016 as well as the first and third paragraphs which grants exemption to Mr. Maramag from the five (5) meter setback requirement.


RESOLVED FINALLY, that copy of this resolution be furnished all concerned for their information and appropriate action.


