RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE DEL R. DE GUZMAN, TO ENTER INTO AND SIGN THE RENEWAL OF A SERVICE AGREEMENT WITH TRIPH INTER-ISLAND INFORMATION SYSTEMS, INC. RELATIVE TO THE PROVISION OF PREMIUM ACCESS TO THE GLOBAL INTERNET AND ADVANCE INFORMATION TECHNOLOGY INFRASTRUCTURE SERVICES FOR THE MARIKINA CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE

WHEREAS, on February 5, 2014, the City Council adopted Resolution No. 008, Series of 2014 which authorized the City Mayor, Honorable Del R. De Guzman to enter into and sign a Service Agreement with Tri.ph Inter-Island Information Systems, Inc. relative to the provision of premium access to the global internet and advance information technology infrastructure services for the Marikina City Disaster Risk Reduction and Management Office (MCDRRMO);

WHEREAS, said Agreement was for a period of two (2) years and will expire in June of the current year, thus the need for a renewal;

WHEREAS, Tri.ph will be upgrading the internet access they are currently providing to the MCDRRMO with a speed of 32mbps from the current speed of 24mbps but with the same rate of One Hundred Fifteen Thousand Pesos (₱115,000.00) per month;

WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in a Service Agreement (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign the renewal of a Service Agreement with TRI.ph Inter-Island Information Systems, Inc. for the provision of premium access to the global internet and advance information technology infrastructure services for the Marikina City Disaster Risk Reduction and Management Office.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, and other concerned offices for their information and appropriate action.
