WHEREAS, on April 27, 2016, the City Council of Marikina adopted Resolution No. 063, Series of 2016 entitled, "Resolution Authorizing the City Mayor, Honorable Del R. De Guzman, to enter into and sign a Merchant Agreement Point-Of-Sale Payment System between the City Government of Marikina and Development Bank of the Philippines, for the use of Credit and Debit Card Transactions for the Payment of Local Government Taxes, Fees and Services;

WHEREAS, the aforementioned Resolution is one of the requirements needed to implement the payment of real property taxes and other payments through banks, on-line ATM and Credit Card Payment by virtue of Ordinance No. 123, Series of 2008;

WHEREAS, for this purpose, there is a need to open a bank account with the Development Bank of the Philippines to closely monitor collections on all taxes, fees and charges received in the Point-Of-Sale (POS) and Online Payment;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the opening of a bank account with the Development Bank of the Philippines for payments made on all local government taxes, fees and charges received through Point-Of-Sale and Online Payment, thereby authorizing the City Treasurer of Marikina, on behalf of the City Government of Marikina, to open said account.


