WHEREAS, on April 8, 2016, St. Gabriel of Our Lady of Sorrows Parish thru its Parish Priest, Rev. Fr. Renato P. Ventajar sent a letter of appeal to the City Council to be exempted from the five (5) meter setback requirement as well as the parking space requirement for the improvement of the existing parish columbarium located at 143 Narra St. corner East Drive, Brgy. Marikina Heights, this City;

WHEREAS, series of committee hearings were conducted with the presence of the City Technical Committee on Housing, Zoning, Urban Planning and Community Development composed of the City Engineer and Building Official, City Legal Officer, City Planning and Development Officer and City Assessor to determine the substance of the request;

WHEREAS, upon a thorough review and discussion regarding the matter, the committee unanimously agreed to grant exemption as requested;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA in session duly assembled, to grant exemption to St. Gabriel of Our Lady of Sorrows Parish from the five (5) meter and parking space requirement.


RESOLVED FINALLY, that copy of this resolution be furnished all concerned for their information and appropriate action.


