**WHEREAS**, as provided by Republic Act No. 9994 otherwise known as the *Expanded Senior Citizens Act of 2010*, the state is duty-bound to recognize the rights of senior citizens by providing support through various social systems;

**WHEREAS**, Section 5 paragraph c of R. A. 9994 provides that:

*" x x x The DOH, in coordination with local government units (LGUs), NGOs and POs for senior citizens, shall institute a national health program and shall provide an integrated health service for senior citizens. It shall train community-based health workers among senior citizens and health personnel to specialize in the geriatric care and health problems of senior citizens. x x x";*

**WHEREAS**, senior citizens, because of their physical frailty due to advanced age or when they are ill, cannot get to the City Health Office or to the clinics of their private doctors to seek medical help or for medical consultation;

**WHEREAS**, all barangays have their own health centers which provide primary health care services that give high importance to education, nutrition, preventive medicine and treatment of the most common diseases and injuries including some medicines which are free for the constituents of the barangays;

**WHEREAS**, doctors should be assigned in all the barangays in Marikina City following a certain schedule of medical services to be provided to these senior citizens;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA** in session duly assembled, to request as it hereby requests the City Government of Marikina thru the City Health Office to assign a doctor in every barangay to conduct scheduled medical services for the senior citizens residing therein;

**RESOLVED FINALLY**, that copies of this Resolution be furnished the Honorable City Mayor Del R. De Guzman and City Health Officer Dr. Alberto P. Herrera for their information and appropriate action.


