RESOLUTION ENJOINING ALL GOVERNMENT HOSPITALS IN MARIKINA CITY TO PUT UP GERIATRIC WARDS FOR SENIOR CITIZENS AND EXTEND APPROPRIATE MEDICAL ASSISTANCE TO THEM WHEN NEED ARISES IN ACCORDANCE WITH REPUBLIC ACT NO. 9994 OTHERWISE KNOWN AS THE EXPANDED SENIOR CITIZENS ACT OF 2010

WHEREAS, as provided Republic Act No. 9994 otherwise known as the Expanded Senior Citizens Act of 2010, the state is duty-bound to recognize the rights of senior citizens by providing support through various social systems;

WHEREAS, Section 5 of RA 9994 provides that:

" x x x Throughout the country, there shall be established a "senior citizens' ward" in every government hospital. This geriatric ward shall be for the exclusive use of senior citizens who are in need of hospital confinement by reason of their health conditions. However, when urgency of public necessity purposes so require, such geriatric ward may be used for emergency purposes, after which, such "senior citizens' ward" shall be reverted to its nature as geriatric ward x x x";

WHEREAS, senior citizens would feel more secure during the remaining years of their lives because of this assurance from the existing law that they will have access to quality medical and health services like providing geriatric wards in public hospitals;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA, in session duly assembled, to enjoin as it hereby enjoins all government hospitals in Marikina City to put up geriatric wards for senior citizens and provide appropriate medical assistance to them when need arises in accordance with Republic Act 9994 otherwise known as the Expanded Senior Citizens Act of 2010.


