RESOLUTION REQUESTING THE HOUSE OF REPRESENTATIVES TO INCLUDE MARIKINA CITY'S FUND ALLOCATION FOR THE KALSADA (KONKRETO AT AYOS NA LANSANGAN ANG DAAN TUNGO SA PANGKALAHATANG KAUNLARAN) AND BOTTOM-UP BUDGETING (BuB) PROGRAMS FOR INCLUSION IN THE "GENERAL APPROPRIATIONS ACT OF 2017"

WHEREAS, the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG) sent a letter dated April 23, 2016 addressed to the Honorable Mayor Del R. de Guzman, citing the national programs and services and their benefits to the LGUs like broadening their technical capacities, improve governance and effective service delivery to their constituents;

WHEREAS, the City Council of Marikina through its Executive Branch strongly support the Konkreto at Ayos na Lansangan ang Daan Tungo sa Pangkalahatang Kaunlaran (KALSADA) and Bottom-Up Budgeting (BuB) programs of the national government which are meant to fund the upgrading and rehabilitation of city roads and bridge thus making the city safer and more equipped to cater to the needs of the Marikeños;

WHEREAS, Section 455 (4) (ii) of the Local Government Code of 1991 provides that:

“(ii) Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities x xx”;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA** in session duly assembled to request the House of Representatives to Include Marikina City’s Fund Allocation for the KALSADA (Konkreto at Ayos na Lansangan ang Daan Tungo sa Pangkalahatang Kaunlaran) and Bottom-Up Budgeting (BuB) Programs for Inclusion in the “General Appropriations Act of 2017”.

RESOLVED FURTHER, that this Resolution be forwarded to the House of Representatives for their information and appropriate action.

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Honorable City Mayor Del R. de Guzman, the City Engineering Department, the City Planning Office and other concerned departments/offices of the city government for their information.






