RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE DEL R. DE GUZMAN, TO ENTER INTO AND SIGN A MOBILE APPLICATION DEVELOPMENT AGREEMENT WITH UPRISE ADVANCED MOBILE DEVELOPMENT CORPORATION FOR THE PURPOSE OF DESIGNING AND DEVELOPING THE CITY'S MOBILE ORDERING SYSTEM

WHEREAS, UPRISE Advanced Mobile Development Corporation is a private company engaged in the business of developing and designing mobile application solutions;

WHEREAS, the developer intends to create a platform that will promote the City of Marikina and provide convenience to its users regarding matters of the City;

WHEREAS, the Application System will be composed of three parts – 1) web services and database, 2) iPhone Application, 3) Android Application;

WHEREAS, in exchange of a fee of Six Million Five Hundred Thousand Pesos (P6,500,000.00), the developer will produce an application system with the following features:

- Web to Mobile Integration
- CCTV Viewing for the User
- Talk2Mayor
- Emergency and Disaster Preparedness Plan
- Emergency Response
- Weather Alerts
- Traffic Routes

WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in a Mobile Application Development Agreement (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Mobile Application Development Agreement between the City Government of Marikina and UPRISE Advanced Mobile Development Corporation for the purpose of designing and developing the City’s Mobile Ordering System.



RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, UPRISE Advanced Mobile Development Corporation, herein represented by its Co-founder and CEO, Jose Antonio Lim Chiong, and other concerned offices for their information and appropriate action.
